

The name behind the store brand

Standing in an aisle at a Walgreens, Steven Lauer had a decision to make. Pay full price for Scope's liter of mouthwash or save a buck with the store's own version, Fresh Breath. "I knew if I liked it I would never buy the Scope again," says Mr. Lauer, who ended up switching to the store brand.

That was 15 years ago. Now he's CEO of Topco Associates LLC, which buys private-label consumer products in bulk on behalf of the 63 supermarkets and wholesalers that are members of its cooperative.

Skokie-based Topco leverages the buying power of its member-owners—second only to Wal-Mart Stores Inc.—to negotiate cheaper prices from vendors for products ranging from canned peas to diapers. Each store then sells the products under its own label or as one of Topco's 18 brands, such as Food Club and Top Care, at cheaper prices than national brands. Companies like Meijer Inc. pay Topco a membership fee and a commission of less than 1% on sales.

To ensure its private-label brands are up to par with national ones, Topco has a 17-member quality assurance staff that tests 250,000 products a year in its lab. For example, a staff member will weigh the pepperoni, cheese and other toppings of a best-selling DiGiorno's pizza against Topco's version.

Topco dates to 1944, when a group of Wisconsin grocers formed Food Cooperatives Inc. to get dairy products and paper goods during wartime shortages. In 1950, it merged with a frozen food cooperative called Top Frost and adopted the name Topco Associates.

Sales hit a low of \$3.2 billion in 2000 amid a consolidation in the market, but have since grown 128%, to an all-time high of \$7.3 billion last year. Topco attributes the rebound to its introduction of new national brands, including one featuring unconventional products like peach and pineapple salsa and the Full Circle organic line, which doubled in revenue last year.

Topco has also made two strategic acquisitions, including last year's purchase of BrainTree Sourcing LLC, which specializes in buying cash registers and other equipment for supermarkets.

Moving up in the numbers world

The kid brother to the nation's Big Four is growing up.

Grant Thornton LLP has been playing catch-up ever since accountant Alexander Grant left Ernst & Ernst in 1924 to start a new firm specializing in mid-sized companies.

By 1985, Grant Thornton had become the ninth-largest U.S. accounting firm by revenue, just behind that era's Big Eight. More mergers and the

eventual collapse of Arthur Andersen LLP in 2002 catapulted the firm into its current No. 5 spot.

"The upheaval of Andersen was a big boon to the remaining firms because the Big Four didn't have the capacity to do all the work," says S. Scott Curtin, Grant Thornton's managing partner in Chicago.

For years, the big accounting firms—Deloitte & Touche USA LLP, Ernst & Young LLP, KPMG LLP and PricewaterhouseCoopers LLP—had a lock on Fortune 500 companies. Then the Sarbanes-Oxley Act of 2002, enacted in the wake of corporate scandals like Enron Corp., shook up the industry by creating billions of dollars of new audit work.

The added demand, plus a shortage of accountants, forced the Big Four to focus on their largest, publicly held companies, pushing the rest downstream to second-tier firms like Grant Thornton or BDO Seidman LLP, also based in Chicago.

In 2004, the first year auditors were required to certify a company's internal controls against fraud, the Big Four firms shed 33% of their clients affected by the new law, up from 21% two years earlier, according to AuditAnalytics.com. Grant Thornton, which has seen its revenue grow 152% in the last five years, to \$886 million in 2006, was one the biggest winners.

Last year, Grant Thornton expanded into three areas, including a health practice started in January and a tax division in its Miami office to serve multinational clients. In October, it bought the restructuring division of Michigan-based Stout Rissius Ross Inc., doubling its new recovery and reorganization practice, which provides professional services to financially troubled companies.

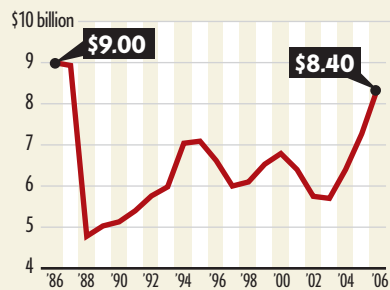

Buying a little piece of paradise

Before Disney's Epcot Center became a showcase for innovation, Shell Vacations LLC was pioneering a new concept called time shares, and building them down the street.

"There was talk about this thing called Epcot coming, and we thought, 'What better place could there be to open a time share?'" says Sheldon Ginsburg, one of the company's founders.

So, in 1978, Shell Vacations bought 150 acres next to Disney World in Orlando, Fla. By the time Epcot Center opened in 1982, Shell had completed a 98-unit apartment complex and had sold units to buyers who got to occupy the vacation homes for a few weeks a year.

Today, Shell, which has since sold the Orlando property, has 110,000 member-owners and operates 23 vacation resorts, predominantly in Hawaii and along the West Coast.

With time sharing, members purchase the right to stay at a resort for a specified number of days each year. Time also can be exchanged for stays at other resort properties.


At Shell Vacations, members on average pay a one-time fee of \$10,000 to \$12,000, which gives them 2,200 points a year. Based on time of year and availability, each resort has different point requirements for a stay. For instance, with 2,000 points, a member could spend a week in a one-bedroom unit at the Staff Pass Golf Suites in Tucson, Ariz., or a weekend in a studio unit at the Donatello in San Francisco.

Shell Vacations has been benefiting from a time-share boom, growing 79% in the last five years to \$388.4 million in revenue. Nationally, the 1,600-plus U.S. resorts offering time shares took in \$6.1 billion in 2005, up 9.1% from the previous year, according to the American Resort Development Assn., an industry trade group.

Even so, it's not an easy sale to the 95% of U.S. households that don't own a time share, Mr. Ginsburg says. "Time sharing to this day is not a sought-after commodity," he says. "No one wakes up and says, 'I want to buy a time share.' They have to be convinced to come to a presentation."

To boost profits, in 2004 Shell Vacations began franchising its points system to outside resort owners, who pay a fee to become a part of Shell's membership group. So far, two resorts—Salado Creek Villages in San Antonio and Crotched Mountain in Franconia, N.H.—have signed on and two more will be announced this spring.

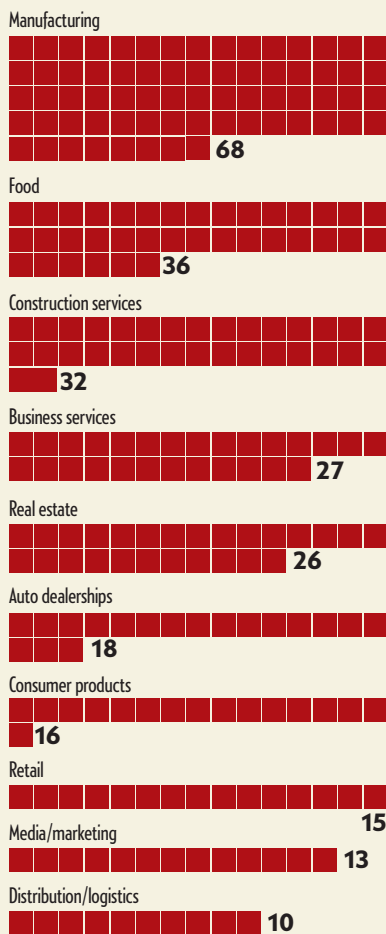

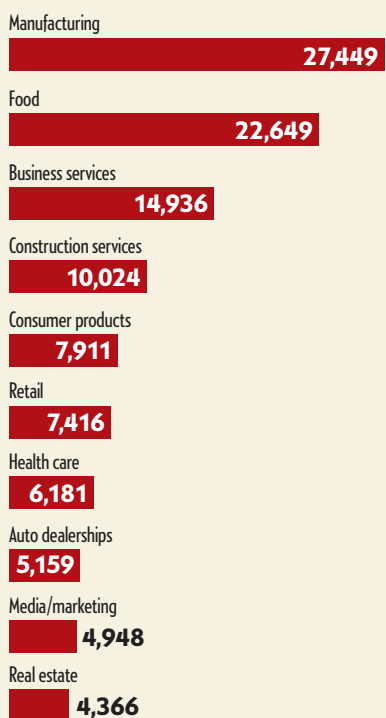

(Revenue in millions. Stock charts show monthly closes from time company went public to April 7, 2007.)

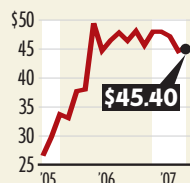

Furnishing it all for the masses

When office furniture salesman Raymond Riha started his own Chicago dealership in 1955, America's pencil pushers required only basic file cabinets, desks and chairs to get the job done.

Since then, office furniture has become more complicated.

These days, 70% of workers toil in cubicles, which are more difficult to configure and install than free-standing furniture. And manufacturers provide seemingly limitless colors, ergonomic chairs, recyclable carpeting and custom-built pieces to companies that want to convey their corporate identity through office design.

The changes have been a boon to retailers. Last year, U.S. companies spent \$12.9 billion on new office furniture, according to the Business and Institutional Furniture Manufacturer's Assn., which expects sales to grow 8% for each of the next two years as new ideas for enhancing productivity, like shrinking private cubicle space and adding cozy meeting places, gain traction.

Mr. Riha's company, OEC Business Interiors Inc., which now sells other office fixtures like lighting and carpeting in addition to desks and chairs and operates a workshop that does repairs and manufactures custom pieces, has grown along with the market. Last year, sales were \$77.4 million, eclipsing the \$265,000 the company brought in 50 years ago.

But growth hasn't been a consistently upward climb. Revenue was higher in 2000, at \$93.4 million, but the economy stumbled after Sept. 11, and companies put their remodeling plans on hold.

OEC, which has sales offices in Chicago and Richmond, Va., got through the lean years by adding more mid-sized businesses to its customer list. OEC's brisk 30% growth for each of the past two years is mostly due to the economy rebounding, says Marketing Manager Jerry Schiro.

Riha family members have been OEC's sole owners since Mr. Riha and his wife, Frances, bought out the other two founding partners in the 1970s. Their son Raymond Riha Jr., 50, is executive vice-president and general manager, son-in-law George Deolitsis is senior vice-president for sales, daughter-in-law Sherrie Riha is vice-president of sales and marketing and two granddaughters also recently joined the company.

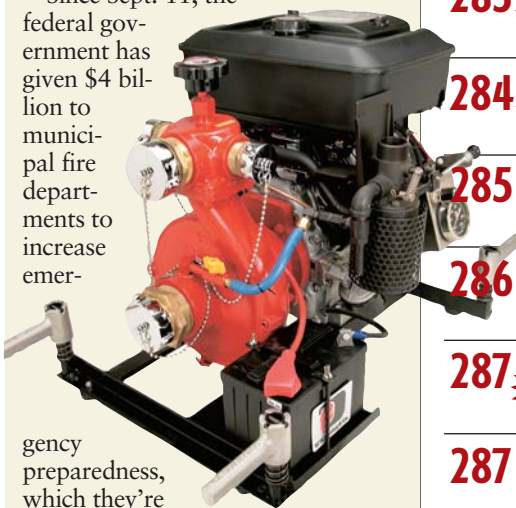

How do you say 'profit' in Chinese?

Weapons factories aren't the only businesses that profit from troubled times. Take W. S. Darley & Co., which makes fire trucks, pumps and firefighting equipment.

Since Sept. 11, the federal government has given \$4 billion to municipal fire departments to increase emergency



preparedness, which they're doing in part by purchasing new equipment from Darley. U.S. soldiers in Iraq and Afghanistan also need firefighting gear. Last year, a single order from the coalition of forces in Iraq brought in \$3 million.

All this adds up to higher sales. Last year, revenue was \$57.5 million, up 11% from the previous year, according to Darley.

It's not the first time conflict has given the company a boost. During World War II, Darley supplied the U.S. military with thousands of pumps, many of which were left behind in Europe, Asia and Australia when the troops returned. That jump-started Darley's international business, unusual for a company of its size. Today, 25% to 30% of its revenue comes from sales overseas.

When Chicago inventor William Stewart Darley started the company in 1925, he cut manufacturing costs by attaching a firetruck cabin to a Ford chassis rather than to a custom-built frame, allowing him to sell a truck for \$695. New towns that couldn't afford the \$5,000 vehicles offered by other manufacturers lined up at Darley's door.




When competitors tried to squelch his success by getting pump manufacturers to stop selling to him, Mr. Darley hired the chief engineer away from one of those companies and started his own pump factory in Chippewa Falls, Wis., in 1932. Darley still runs that plant, plus another in Toledo, Ore. Pumps are its core business, accounting for 45% of revenue.

The company, now run by three of Mr. Darley's grandsons, Paul, Peter and Jeff, plans to expand by starting a new division to build custom pumps for other firetruck companies and finding new uses for its pumps, like purifying water.

More overseas business is in the offing, too, particularly from China, which buys more than \$10 million worth of pumps from Darley a year. Yankee ingenuity is not the only appeal for these customers.

"As luck would have it, the word 'Darley' sounds like 'Da-li,' which means 'strength' in Chinese," Paul Darley says.
